Note that 203's Operating Expense Per Pupil is \$3,511 less than the average for all 6 districts compared.

Operating Expense Per Pupil, is the ISBE calculation of the cost of operating a school district. It does not include "bricks and mortar" expenses such as Capital Expenditures or Bond Principal Retired. It also does not include summer school or adult education. This ISBE calculation is based on AD (average daily attendance) not enrollment and can not be independently calculated from the financial data provided on the report card. Lastly, the financial figures reported on the report card are one year behind, meaning that these numbers reflect the 2012-2013 school year.

The Illinois College Readiness Score is the percentage of all test takers who scored at least a 21 on the ACT. This is different than how ACT creates their readiness score.

While District 203 includes Elementary, Jr. High and High Schools, most towns have separate Elementary/Jr. High Districts feeding into a High School District For the 7 above we took the HS district costs, ACT and PSAE test performance, and added the operating costs and ISAT test scores for the Elementary/Jr. High School Districts feeding into it (on an average daily attendance weighted basis for the costs) to give the reader a very accurate comparison to D203.

Combined Elementary Districts' ISAT score is calculated using a weighted average, based on enrollment.

Combined Yearly Cost, is the weighted average of the high school and feeder school districts OEPP based on their Average Daily Attendance.
